Chairman and members of the Constitutional Council



**MALINOVSKIY Victor Aleksandrovich** was born on May 27, 1956 in Almaty. Has graduated from law faculty of S.M. Kirov Kazakh State university.

His labor activity he has begun as the assistant, the senior teacher of faculty of state law and the Soviet construction, the assistant to the dean of a faculty of law of S.M. Kirov Kazakh State university, the senior lecturer of faculty of the state construction and law of Almaty institute of political science.

Worked as the reviewer, senior reviewer of the State-legal department of the Administration of the President and the Cabinet of the Republic of Kazakhstan, the judge of the Constitutional Court of Republic. From 1995 to 2006 worked as the pro-rector of Academy of jurisprudence - the Higher school of law "Adilet". Recently worked as the lawyer in "Internews - Kazakhstan", managing faculty of constitutional law Abay Kazakh National Pedagogical University.

The doctor of law. Defended graduation papers on the master's degree (1985) and the doctor's degree (2004) on a special subject 12.00-02 in M.V.Lomonosov Moscow state university.

The permanent participant of the constitutional process. In 2006-2007 was the expert of working group on prospects of the constitutional reforms of the Republic of the State commission headed by the President on development and a concrete definition of the program of democratic reforms in Kazakhstan, and also Working group on preparation of a bill of making amendments and additions to the Constitution of the Republic of Kazakhstan (on May 21st, 2007).
